Directions to Doubletree Hotel Bay City – Waterfront

From the Detroit Area: Follow I-75 North to Exit 162A (M-25 East) toward downtown Bay City. Continue on M-25 East / Thomas Street. Cross over Veterans Memorial Bridge and turn left on Saginaw Street. Turn left on 6th Street, entrance will be straight ahead.

From the Lansing/Jackson Area: (Jackson – 127 North to 27) Follow 27 North to M-20 East and M-20 to US-10 (Business) East. US-10 East toward Bay City. US-10 becomes M-25 East/Thomas Street. Cross Veterans Memorial Bridge and turn left on Saginaw Street. Turn left on 6th Street, entrance will be straight ahead.

From Grand Rapids/Muskegon Area: Follow 131 North to M-46, then to M-66 North and them to M-20 East and M-20 to US-10 (Business) East. Follow US-10 East toward Bay City. US-10 becomes M-25 East/Thomas Street. Cross Veterans Memorial Bridge and turn left on Saginaw Street. Turn left on 6th Street, entrance will be straight ahead.

From Battle Creek/Kalamazoo Area: Follow 94 to 69 North/East to US-27, then North to M-20 East and M-20 to US-10 (Business) East. Follow US-10 East toward Bay City. US-10 becomes M-25 East/Thomas Street. Cross Veterans Memorial Bridge and turn left on Saginaw Street. Turn left on 6th Street, entrance will be straight ahead.

From the Gaylord Area: Follow 27 South to US-10 East toward Bay City. US-10 becomes M-25 East/Thomas Street. Cross Veterans Memorial Bridge and turn left on Saginaw Street. Turn left on 6th Street, entrance will be straight ahead.

From the Alpena Area: Follow US-23 South to I-75 South to Exit 162A (M-25 East) toward downtown Bay City. Continue on M-25 East / Thomas Street. Cross over Veterans Memorial Bridge and turn left on Saginaw Street. Turn left on 6th Street, entrance will be straight ahead.

From the Traverse City Area: Follow M-37 South to M-115 South/East to US-10 South/East, to Midland, Follow US-10 East toward Bay City. US-10 becomes M-25 East/Thomas Street. Cross Veterans Memorial Bridge and turn left on Saginaw Street. Turn left on 6th Street, entrance will be straight ahead.
