All-State Program

Comrades the 2017-2018 reporting period started May 1, 2017 and ends April 30, 2018. There have been a few *Changes* to the program for this year. So *Please* read the program in the 2017-2018 commander's roster or department web-site under programs (All-State) in its entirety. So you understand what is required and Who and Where to send reports and Deadline Dates.

The 2017-2018 All-State checklist and Commander's entry form can be found on the department website. You can print copies from the site (All-State checklist). Also I have copies at every VTS training we hold. The All-State checklist is provided so the post can keep track of their points, it's your responsibility.

Some All-State Program Statistics:

There are 375 Points (not including points tied to membership) of that 127 points (are tied to donations) 248 points can be attained by not donating a penny. Only 125 points is needed with membership requirement with 100% + 1 new member to achieve All-State honors.

County Council and District All-State Commander requirements are different so please refer to 2017-2018 Department Commander's roster or the 2017-2018 All-State County Council or District Commander's Program on the department Web-site.

All-State Judging has been changed to May 2, 2018

In Closing (3) VERY Important requirement's to adhere to...

- 1. All-State Check List and Commander's entry form for all Post, County Council and District Commanders must be received at the Department Headquarters by April 30,2018 for All-State honors consideration (No Exceptions)
- 2. If 125 points has been achieved by the post by April 30,2018 and there All-State checklist and Commander's entry for is into Department Headquarter by that date, but the post, County Council or District is shy of the membership requirement of 100% +1 New member. Post will be allowed to continue recruiting until June 30,2018
- 3. Not a requirement but Highly Recommended. Once Again Only Use and Reference the 2017-2018 All-State Program for Directions, Program requirements and Deadline Dates.

painstakingly complete form after form by hand and submit to the VA for processing.

At the regional office our service officers and claims consultants would receive the claims in bundles from the field or from the postal service. It was not uncommon to process dozens of claims and hundreds or perhaps thousands of forms and documents on a day-to-day basis. The sheer volume of claim work going to the VA daily would astound the average citizen. I'm fond of saying if our service officers did nothing more than process mail rather than answer phone calls, return emails, and conduct interviews, we would still have a full day.

Although much has changed over the past decade and a half, especially with technology, our service officers and claims consultants still have a full day's work and then some. We still receive paper claims from the field as we have those clients who steadfastly refuse to use a computer. That's okay. There are times I'm not fond of them myself.

Today our service office staff uses such programs as Direct Upload, Digit to Digit (D2D), and packaged claims to file claims electronically with the VA. Our field representatives often travel from assignment to assignment armed with a laptop computer, a scanner, and a signature pad. Sometimes they use a printer, while more often than not the printer is relegated to the same status as a rotary dial telephone. (What's that, you ask?). Quite often no paper forms are signed or submitted. Having a claim lost in cyberspace is less likely to occur than sending it through the mail, but it still happens on rare occasions.

We use VA programs such as VBMS (Veterans Benefits Management System) which allows us to see almost a complete digital history of the veteran's service from pre-enlistment forward. Obtaining a copy of a DD 214 often requires just a few strokes of the keyboard. Previously we had to order a paper claim folder from the VA which could be very time consuming as sometimes the folder could be at another regional office or in long term storage in St. Louis or Kansas City.

Another aspect of our job is appellate work. This can be a labor intensive and time consuming endeavor, but when we gain a victory for the veteran or surviving family member we consider our efforts to be well worth it! If a hearing has been requested, we and the veteran formulate a plan as to the content of the testimony we will present to the Decision Review Officer of Board of Veterans Appeals Veterans Law Judge. Rather than wait for a traveling team of judges from Washington, DC most hearings now take place via video teleconference. Although our job is still hectic, technology has changed the way we do our job for the better!

I have been working an issue with a local resident of Oakland County. She found nine unmarked graves for WW2 KIAs. We launched an effort with the VA Regional office in Detroit to order markers from the National Cemetery Administration. Seven of the applications have been approved and a ceremony honoring these veterans with be this Sunday, email with directions below

Service is held at 4 Freedom Memorial at White Chapel Cemetery. There will be a parade that will start at noon and goes to the 4 Freedom Memorial. Service will start as soon as the parade arrives, so it looks like about 12:10pm. Hope to see you there. I will have DAR ladies stationed at all the grave sites. I will be wearing my DAR Badge. My phone number is 248-693-7674, if you want to text me when you get there. We have family coming from Zoulek, I am working on getting a flag presented to the family.

Success Story

During the course of a service officer's career he or she may submit thousands of claims. While several may stand out for one reason or another, for the most part it is all in a day's work and part of the routine nature of our job. We interview, complete the necessary forms, submit the claim and wait for the outcome. We had one claim that disrupted that pattern completely.

We received a phone call from a family friend of a World War II veteran. Although all of our encounters with this exceptional group of veterans are special, this particular case would prove exceptional. Adelore Palmiter was a patient at the Ann Arbor VAMC. Mr. Palmiter was just one of 23 living survivors of the USS Indianapolis. As you may recall this ship was on a classified mission when it was hit by two torpedoes and sunk. Of 1,196 sailors on board only 317 survived. Many of the survivors suffered from exposure, salt poisoning, and shark bites. Mr. Palmiter was just 18 years and three months old when the ship departed San Francisco bound for Tinian Island. Two weeks later he was fighting for his life in the shark-infested waters of the Pacific Ocean.

Mr. Palmiter had once before attempted to file a claim for benefits, but the process of remembering the tragic events had proved overwhelming at the time. Several years later he decided to try again. He was an inpatient at the Ann Arbor facility when the claim was filed. He was in poor health and very frail, but was bravely determined to complete the task this time. Unfortunately, Mr. Palmiter succumbed to the various illnesses that had plagued his body for years.

Not willing to allow the passing of this sailor to bring a halt to the claim and realizing there was a surviving widow our office pressed ahead. Several roadblocks had to be navigated. The process was not easy and required coordinating with VA offices in both Detroit and Washington, DC. At the Regional Office the Assistant Service Center Manager became involved and likewise a VA congressional liaison. They worked tirelessly and passionately to see to it the widow received the maximum benefits allowed

by law. Additionally, the VFW's National Veterans Service in Washington, DC also became involved.

It was a total team effort that ensured this extraordinary veteran's legacy will be honored!

They also managed to raise over \$26,000. As I attended several organizational meetings it was inspiring to see the enthusiasm these young adults had for wanting to pay tribute to Vietnam Vets.

The project was simple on intent and yet complex by design. An effort of this magnitude would take hundreds of volunteers and thousands of hours donated to pull it off. As I watched and observed the final stages of this project coming together, I couldn't help but wonder what the driving force was behind the desire to honor these who served in Vietnam and why

should high school student 50 years removed from the war even care? They would have no recollection of events of what was going on in the 1960s first hand. I can't say for certain, but it is my belief their parents and educators had a great deal to do with the desire and motivation it took to bring the wall here. Each time I spoke to one of these young people I was greeted with respect and dignity.

From the opening ceremony Thursday night to the candle light vigil on Friday and the pinning ceremony on Saturday, "the wall" was well attended by hundreds of veterans and their families. Congratulations to all of you for making Memorial day 2017 a memorable reality. Because of your patriotism and love of freedom you have ensured or legacy will live on to future generations. AWESOME!!!! Well done!

A life was saved because of one member. This shows how one member made a difference in a veteran's life. 22 Veterans commit suicide every day. They need our help.
